ROAD AND VERGE MAINTENANCE AND TRAFFIC MEASURES

The 2022 Road and Verge repair work was discussed at length during last year's AGM and was recorded in the Minutes. The next major assessment of the road is currently scheduled for 2025. A full survey will be undertaken to ascertain the cost and extent of the work required. The survey will not take place until after the completion of the SGN work and completion of the Little Snakemoor development.

VAS x two are now fully operational. Thanks to residents above the downhill VAS who have pruned their hedges, allowing the device to fully operate.

SGN WORK (mains gas replacement)

The road will be temporarily closed to through traffic and restricted to access only. Temporary foot paths will be made around the roadworks. There maybe a need for a hard closure to one end at a time, for short periods. Full details will be provided to us by SGN which we will share with you. We will give you as much notice of this as we can. The work will last about six weeks.

OBSTRUCTIONS TO VERGES

We have received the following advice from Andrew Barsby, barrister, of Private Roads Services.

"Many of the queries we receive relate to the verges, usually grassed, of private roads. Typically, problems arise because residents wish to assert control over the verge along their frontages, perhaps by installing light, putting up signs or preventing parking on them by means of boulders, posts or fences. Such activities may not be objectionable but residents' associations will be wise to make clear that responsibility (including responsibility for arranging the necessary insurance cover) rests with the residents in question".
