# ROAD AND VERGE MAINTENANCE AND TRAFFIC MEASURES

The road surface has held up reasonably well and we have deferred the next survey to Spring 2025. Depending on the result we may or may not have repairs done in 2025. Potholes are being repaired.

VAS x two are fully operational but there are no data downloads from the downhill VAS.

### ACCOUNTS AND ANNUAL SUBSCRIPTION

The 23/24 accounts are on the website. As at the 31.05.24, total funds amounted to £46,963. The Committee have assessed future expected demands on funds and have decided that the subscription should remain at £85 for the forthcoming year.

### PLANNING AND DEVELOPMENT

There are no current planning developments. However, we have now prepared a Guide for Developers for any future work undertaken which is on our website.

#### TRAFFIC CALMING MEASURES

Please see the attached report from Tim Jones. We will take a vote on the following

- 1. Is there a real need for enhanced traffic calming observing that improvements are likely to be limited and it is expected to cost in the order of £100,000?
- 2. Should we undertake a feasibility study at a cost of £3,300 to find out what can and cannot be done when we would not have the funds to implement such a scheme

### **DRAINAGE**

A drainage study was carried out in 2014. This identified it was not possible to have traditional storm drainage due to the gradient of the hill and soakaways were the only option worth pursuing. It was also noted that tree roots and services would be an issue in certain locations. No further action was taken. However, due to the high levels of rain we have been having the committee has decided this is an area requiring further exploration. We have thus appointed Paul Basham Associates to attend a site meeting and prepare a report to identify possible solutions and constraints. It is hoped we will be in a position to report further at the AGM.

#### LEAF SWEEPING

We plan to carry out leaf sweeping again this year which will take place in early December.

# KINGS CRESCENT

Members of the SHA Committee engaged with Kings Crescent following last year's AGM and they have paid £500 contribution this year. We feel this is an appropriate way forward as a number of the properties are either rented or empty.
