Proposal: Pruning / lopping of any trees in the vacinity of street lights which are causing shadow and obstruction of street lighting. No branch over 30mm diameter will be pruned and then by no more than 2 metres. A blanket application is requested with approval for 5 years as this would give us flexibility and would obviate the need to make individual applications.

In pursuance of its powers under the above mentioned Act and Regulations, the Council, as the Local Planning Authority, GRANTS Tree Preservation Order Consent to the above works in accordance with the plans and particulars submitted with your application received 31 July 2018 and subject to compliance with the following conditions if specified hereunder:

1 Standard of work

The tree works hereby consented shall be carried out in accordance with BS3998:2010 Tree work - Recommendations or any subsequent revisions

1 Reason for condition: to minimise the impact of the tree works on the health and visual amenity of the tree(s).



 The work hereby given consent shall be carried out within 2 years of the date of this letter unless otherwise agreed, within this period, in writing by the Local Planning Authority.

Under the Wildlife and Countryside Act (1981), it is an offence to wilfully disturb birds whilst nesting and you are advised to conduct tree work outside the nesting season (March to September). Under the Habitats Directive (1992) it is an offence to disturb bats or their habitats (wilfully or otherwise) and you are advised to seek professional ecological advice with regard to likely impact of the works on bats.

Informatives:

O Biosecurity Measures: To minimise to potential for contamination of the tree from other tree works it is appropriate to sterilise tools to be used before and after the works are implemented.
